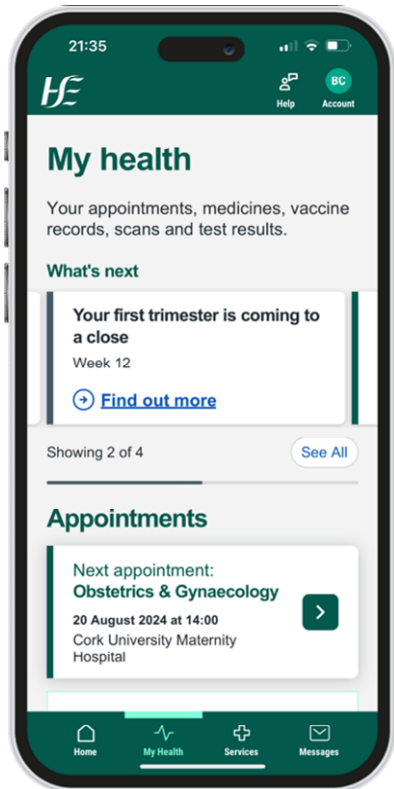

Core Principles

The roadmap is built on six strategic principles



Patient as an Empowered Partner:

Patients gain greater control over their health information.



Workforce and Workplace:

A digitally skilled workforce with the right tools to enhance care delivery and efficiency.



Digitally Enabled and Connected

Care: Seamless integration of Healthdata to support coordinated, evidence-based care.



Data-Driven Services:

Enhanced data access and analytics for better resource management and patient outcomes.



Digital Health Ecosystem and

Innovation: Fostering innovation and collaborations across the healthcare ecosystem.



Secure Foundations and Digital

Enablers: Ensuring robust governance, security, and infrastructure.



Virtual Wards

A Virtual Ward is a safe and efficient alternative to bedded care enabled by technology. Virtual Wards support patients who would otherwise be in hospital to receive acute care, monitoring, and treatment in their own home, thus preventing avoidable hospital admissions, or supporting early discharge.

"Virtual wards have evolved from pressures healthcare systems face in unscheduled care, pressures which increased during the pandemic" -

HSE chief clinical officer Dr Colm Henry. For some patients, monitoring by clinical teams who harness technology can offer a safe and preferable alternative to inpatient hospital care. It enables individuals to take an active role in managing their health and well-being.

Strategic Initiatives

To achieve these principles, 48 strategic initiatives have been identified, prioritised, and are being implemented over a six-year period.

These initiatives include:

- A HSE Health app
- Virtual Wards
- Implementation of Electronic Health Records (EHRs)
- Development of a National Shared Care Record
- Expansion of telehealth services
- Establishment of digital health innovation hubs
